REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

In view of the COVID-19 outbreak and as part of the safety measures, the Postponed 41st AGM of the Company will be held on a virtual basis through live streaming and online remote voting from the Broadcast Venue using the Remote Participation and Voting Facilities ("RPV").

The Company has appointed Tricor Investor & Issuing House Services Sdn Bhd ("Tricor") as the Poll Administrator for the Postponed 41st AGM to facilitate the RPV via its TIIH Online website at https://tiih.online. This is in line with the Government's Directive and Guidance Notes on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia to curb the spread of COVID-19 on 18 April 2020 and last revised on 16 July 2021.

As the COVID-19 situation in Malaysia is constantly evolving, we may be required to change the Postponed 41st AGM arrangements at short notice. Please visit Bursa Malaysia Securities Berhad's website or the Company's website at https://www.gentingmalaysia.com/agm/ for the latest announcements relating to the Postponed 41st AGM.

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which stipulates that the Chairperson of the meeting shall be present at the main venue of the meeting. Members **WILL NOT BE ALLOWED** to attend the Postponed 41st AGM at the Broadcast Venue in person on the day of the meeting.

Members are to attend, speak (in the form of typed text messages) [attend and speak (in the form of typed text messages) are collectively, "participate"] and vote remotely at the Postponed 41st AGM using RPV provided by Tricor via its **TIIH Online** website at https://tiih.online.

PRE-MEETING SUBMISSION OF OUESTIONS TO THE BOARD OF DIRECTORS

Members may submit questions relating to the ordinary and special businesses set out in the Notice of the Postponed 41st AGM to the Board in advance of the Postponed 41st AGM via Tricor's TIIH Online website at https://tiih.online by selecting "e-Services" to login, pose the questions and submit electronically not later than **Monday, 20 September 2021 at 10.00 a.m.** or during live streaming on the day of the Postponed 41st AGM itself by typing the question in the query box via the RPV. Priority will be given to questions which were submitted ahead of the 41st AGM and Postponed 41st AGM. If time permits during the meeting, the Board will try to respond to those relevant questions relating to the businesses to be discussed at the Postponed 41st AGM which are submitted via the RPV during live streaming.

Questions which are not related to the Postponed 41st AGM will not be answered by the Board.

MEMBER WHO IS AN INDIVIDUAL PERSON

A member who is an individual person and wishes to participate and vote remotely at the Postponed 41st AGM of the Company via the RPV must pre-register as a user with TIIH Online. If the member is already a user with TIIH Online, the member is not required to register again.

Upon successful notification of registration as a user with TIIH Online, the member has to submit his/her request for "Registration for Remote Participation and Voting" at https://tiih.online in order to participate and vote at the Postponed 41st AGM via the RPV.

PROXY/(IES)

Members may appoint proxy/(ies) to participate and vote via the RPV at the Postponed 41st AGM of the Company. The appointment of proxy/(ies) may be made in a hard copy form or by electronic means.

For hard copy form submission, the original instrument appointing a proxy shall be in writing and:

- (a) in the case of an individual, shall be signed by the appoint or by his attorney; and
- (b) in the case of a corporation, shall be either under the common seal or signed by its attorney or by an officer on behalf of the corporation.

Duly executed Proxy Forms for Postponed 41st AGM must be submitted in the following manner, <u>not less than forty-eight (48) hours</u> before the time appointed for holding the Postponed 41st AGM or at any adjournment thereof:

(i) In hard copy form

(ii) Via Tricor Online System (TIIH Online)

The Proxy Form for Postponed 41st AGM can be electronically submitted via TIIH Online at https://tiih.online. Please refer to the procedures set out in "ELECTRONIC LODGEMENT OF PROXY FORM ONLY" below.

IMPORTANT NOTES

- The Proxy Form for Postponed 41st AGM DOES NOT INVALIDATE the proxy form which was circulated together with the Notice of 41st AGM dated 7 April 2021 ("Original Proxy Form"). All Original Proxy Forms deposited with Tricor not less than forty-eight (48) hours before the time appointed for holding the meeting or any adjournment thereof shall remain valid and acceptable.
- Subject to the appointer being a member who is entitled to attend the Postponed 41st AGM, the Original Proxy Form that has been deposited with Tricor shall remain valid unless a Proxy Form for Postponed 41st AGM superseding the previous deposited Original Proxy Form (if any) is deposited with Tricor.
- For the purpose of determining members who shall be entitled to attend the Postponed 41st AGM, the Company shall be requesting Bursa Malaysia Depository Sdn Bhd to issue a Record of Depositors as at 15 September 2021. Only depositors whose names appear on the Record of Depositors as at 15 September 2021 shall be entitled to attend the said meeting or appoint proxies to attend and vote on their behalf. For the avoidance of doubt, the Original Proxy Form received from any member whose name is not on the Record of Depositors as at 15 September 2021 shall be deemed null and void.

Members are requested to provide their mobile handphone numbers as well as the mobile handphone numbers of their proxies in the Proxy Forms for Postponed 41st AGM in the event Tricor needs to contact the members/proxies.

The last date and time for the deposit/electronic submission of the Proxy Forms for Postponed 41st AGM is **Monday**, **20 September 2021 at 10.00 a.m.**

CORPORATE MEMBERS

A Corporate Member who wishes to appoint a Corporate Representative to participate and vote remotely at the Postponed 41st AGM of the Company via the RPV must deposit the **original** certificate of appointment of corporate representative (in hard copy) at Tricor's office not later than **Monday**, 20 September 2021 at 10.00 a.m.

The certificate of appointment of corporate representative must be either under seal or signed by a duly authorised officer(s) pursuant to a resolution of its board of directors.

If a Corporate Member submitted more than one (1) certificate of appointment, the latest certificate of appointment shall supersede the certificate of appointment submitted earlier.

Corporate Members are requested to provide their contact details of their officers (office/mobile handphone numbers) as well as the mobile handphone numbers of their corporate representatives in the event Tricor needs to contact them.

The appointed Corporate Representative must register himself/herself for the RPV at https://tiih.online in order to participate and vote at this Postponed 41st AGM via the RPV. NOMINEE COMPANIES

For a Nominee Company registered as a member, the beneficial owner of the shares held under a Nominee Company's CDS account who wishes to participate and vote remotely at the Postponed 41st AGM of the Company via the RPV can request the Nominee Company to appoint him/her as a proxy and deposit the duly completed **original** signed Proxy Form for Postponed 41st AGM (in hard copy) at Tricor's office or submit electronically via TIIH Online at https://tiih.online not later than **Monday**, 20 September 2021 at 10.00 a.m. For online submission, please refer to the procedures set out in "ELECTRONIC LODGEMENT OF PROXY FORM ONLY" below.

The appointed proxy of the Nominee Company must register himself/herself for the RPV at https://tiih.online in order to participate and vote at this Postponed 41st AGM via the RPV. APPOINTMENT OF MORE THAN ONE (1) PROXY

Where a member appoints more than one (1) proxy, the appointments shall be invalid unless he/she specifies the proportions of his/her shareholding to be represented by each proxy. If a member submitted more than one (1) proxy form, the latest proxy form shall supersede the earlier one.

REVOCATION OF PROXIES OR VICE VERSA

If a member submitted a proxy form appointing his/her proxy, the proxy appointment can be revoked should the member decide to personally participate at the Postponed 41st AGM of the Company via the RPV. Please contact the persons stated under "ENQUIRY" section below not later than Monday, 20 September 2021 at 10.00 a.m. to request for revocation. However, if a member who has registered to participate via the RPV for the Postponed 41st AGM subsequently wishes to appoint his/her proxy to participate on his/her behalf, please contact the persons stated under "ENQUIRY" section below and deposit the Proxy Form for Postponed 41st AGM not later than Monday, 20 September 2021 at 10.00 a.m.

MEMBERS UNABLE TO ATTEND MAY APPOINT THE CHAIRMAN OF THE MEETING

As the Postponed 41st AGM is conducted virtually, members who are unable to participate at the Postponed 41st AGM may appoint the Chairman of the meeting as his/her/its proxy and indicate the voting instructions in their Proxy Forms for Postponed 41st AGM and submit either in a hard copy form or by electronic means in the manner set out under "**PROXY/(IES)**" **above**, not later than **Monday**, **20 September 2021 at 10.00 a.m.**

POLL VOTING

The voting at the Postponed 41st AGM will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting (e-voting).

Shareholders/proxies/corporate representatives can proceed to vote on the resolutions at any time from the commencement of the Postponed 41st AGM at 10.00 a.m. on 22 September 2021 but before the end of the voting session which will be announced by the Chairman of the meeting.
